I _____ HEREBY ACKNOWLEDGE that I have voluntarily applied to participate in instruction and training in the starting, training, selection, care, handling, and riding of horses with DOUGLAS MILLS, LYNETTE MILLS dba ERIN VALLEY RIDING STABLES & TRAINING THRU TRUST. 4 - I EXPRESSLY ACKNOWLEDGE AND AGREE THAT activities involving horses involve INHERENT RISKS which mean that there are dangers or conditions which are an integral part of horse activities and include, among other things, the propensity of a horse to behave in ways that may result in injury, harm and/or death and/or property damage to persons on or about them and the unpredictability of a horse's reaction to such things as sounds, sudden movement and unfamiliar objects, persons, or other animals. I FURTHER EXPRESSLY AGREE

THAT the foregoing release, assumption of the risk and indemnity agreement is intended to be as broad and inclusive as is permitted by the laws of the Province/State of _____ and that if any portion hereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect

PROTECTIVE ATTIRE: All person(s) under 19 years of age participating in the riding/handling of horse(s) are required to wear a well-fitted hard hat or ASTM or SEI approved helmet. I am herby advised that it is strongly recommended that I must wear slip-on heeled boots to protect feet when working around or riding horses.

PROTECTIVE ATTIRE: ALL PERSONS OVER THE AGE OF 19 years of age are advised that it is strongly recommended that I must wear slip-on heeled boots to protect feet when working around or riding horses. I am hereby advised that I must wear a well-fitted hard hat or ASTM or SEI approved helmet, fastened securely under the chin, while riding horses. If I choose not to wear a helmet when riding I so state in my own hand
